RESOLUTION AUTHORIZING THE UTILIZATION OF THE 20% EDF (CURRENT) UNDER CONSTRUCTION/CONCRETING/REHABILITATION OF FMR AND BRIDGES WITH ACCOUNT NO. 100-20%-300-1-07-010 IN THE AMOUNT OF SIX HUNDRED SEVENTYFOUR THOUSAND SEVEN HUNDRED PESOS (PHP674,700.00) PESOS FOR THE CONSTRUCTION/REHABILITATION OF SITIO BASAK TO SITIO TIALA FMR.
