

**PREFATORY STATEMENT**

Paranglumba Integrated school is located closely along the municipal road wherein the school populace coming in and out during classes is very hazardous from the passing vehicles.

To prevent vehicular incidents, traffic barriers and/or pedestrian barriers shall be established to minimize the speed of vehicles passing thereat for the safety of the people particularly the school populace hence this enactment.

**BE IT ORDAINED** by the Sangguniang Barangay in session assembled:

**"BARANGAY ORDINANCE NO. 02**  
Series of 2024

**SECTION 1. TITLE.** This shall be known as **"AN ORDINANCE ESTABLISHING MOVABLE SAFETY TRAFFIC OR PEDESTRIAN BARRIERS ALONG THE MUNICIPAL ROAD ALONG THE VICINITY OF PARANGLUMBA INTEGRATED SCHOOL, PARANGLUMBA, SIAYAN, ZAMBOANGA DEL NORTE."**

**SECTION 2. ADMINISTRATIVE PROVISION.** A movable Traffic barriers or pedestrian barriers shall be established within the specified road during classes only and after classes or all students, teachers and other employees of Paranglumba Integrated School went home, the said barriers shall be removed and be properly kept at the roadside.

**SECTION 3. ESTABLISHMENT OF TRAFFIC/PEDESTRIAN BARRIERS.** Traffic barriers/pedestrian barriers shall be established at the municipal road along the vicinity of Paranglumba Integrated School, Paranglumba, Siayan, Zamboanga del Norte.

**SECTION 4. PENALTY.** Any person or group of persons that will cause destruction and intentionally destroy of the aforesaid traffic barriers shall be penalized in the amount of One thousand (P1,000.00) Pesos.

**SECTION 5. EFFECTIVITY.** This ordinance shall take after the declaration in order of the Honorable Sangguniang Bayan of Siayan, Zamboanga del Norte and posting of copies at 3 conspicuous places.




