RESOLUTION REPROGRAMMING THE UNEXPENDED LUMP SUM AMOUNT OF THE 70% MUNICIPAL DISASTER RISK REDUCTION & MANAGEMENT FUND (MDRRMF) OUT OF THE 5% CALAMITY FUND OF THE PREVIOUS CALENDAR YEARS AMOUNTING TO ONE MILLION THREE HUNDRED SIXTY-SEVEN THOUSAND ONE HUNDRED FOUR PESOS AND SIXTY-FIVE CENTAVOS ONLY (P1,367,104.65).
