DECLARING IN ORDER ORDINANCE NO. 02, RESOLUTION NO. 02 AND RESOLUTION NO. 03 BOTH SERIES OF 2023 OF BARANGAY GUIBO, SIAYAN, ZAMBOANGA DEL NORTE AS IT IS WITHIN THE PRESCRIBED POWER OF THE SANGGUNIANG BARANGAY TO ENACT PROVIDED UNDER RA 7160.
