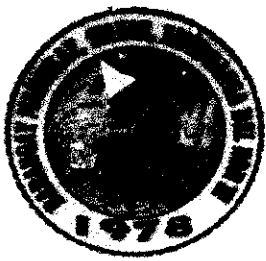

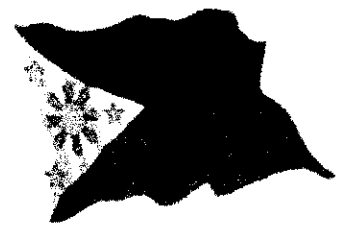

AN ORDINANCE DECLARING BARANGAY CURFEW HOURS IN BARANGAY MANGILAY,  
SIAYAN ZAMBOANGA DEL NORTE AND PRESCRIBING PENALTIES THEREOF.

BE IT ORDAINED by the Honorable Sangguniang Barangay of Mangilay, Siayan,  
Zamboanga Del Norte in session assembled:

**SECTION I. TITLE.** This shall be known as "CURFEW ORDINANCE OF BARANGAY  
MANGILAY, SIAYAN, ZAMBOANGA DEL NORTE.

**SECTION II. DECLARATION OF POLICY.** The hours of 10:00 P.M. to 4:00 A.M. of the  
following day is hereby declared a "CURFEW HOURS" to any person or group of persons within  
the territorial jurisdiction of Barangay Mangilay, Siayan, Zamboanga Del Norte. During curfew  
hours, no person or group of persons shall be allowed in the streets, commercial establishment,  
market and to any places within the territorial jurisdiction of Barangay Mangilay, Siayan,  
Zamboanga Del Norte.

1. Emergency cases for medication or hospitalization.
2. Those running lawful errands such as buying of medicines, using of telecommunication facilities for emergency purposes and the like;
3. Students covering the herein specified ages who attended night school program/activities. Provided that the afforested students are within the premises where the school programs/activities held. All students have given grace time of 45 minutes after the program to go home.

**SECTION IV. ADMINISTRATIVE PROVISION:** The Punong Barangay, Kagawads or Sangguniang Barangay, and duly appointed Barangay Tanods are hereby authorized to apprehend and to hold all violators and be temporary detailed at the night in the Barangay Hall for their safety.

The apprehending official shall, without unnecessary delay, shall noticed immediately inform either the parent, or guardian, of the Fact of the apprehension. That apprehended violators residing in other barangays shall be referred immediately to the Punong Barangay of the offender's places or residence.

**PROVIDED,** that an offender who is homeless, abandoned or neglect or has no known parent, relative, or guardian residing in the Barangay shall be referred, without unnecessary delay, with twelve (12) hours or at the earliest, office hours from the time of apprehension, to the Siayan Municipality Police Station for further verification and investigation.

**SECTION V. PENALTY.** Any person or group of persons who is /are residents of Barangay Mangilay, shall be penalized in the amount of p300;00 pesos, violators from other places shall be penalized in the amount of p300; 00 pesos.

**SECTION VI. EFFECTIVELY CLAUSE,** this ordinance shall take effect thirty days after approval and publications, public information and dissemination and posting of copies in conspicuous places.


