### "RESOLUTION NO. 123

Series of 2023

RESOLUTION REQUESTING THE NATIONAL HISTORICAL COMMISSION OF THE PHILIPPINES (NHCP) AND THE DEPARTMENT OF LABOR TO ISSUE CERTIFICATION AS TO SIGNIFICANCE OF THE OCCASION AND ECONOMIC VIABILITY OF THE HOLIDAY FOR THE SANGGUNIANG BAYAN TO DECLARE NON-WORKING HOLIDAYS OF THIS MUNICIPALITY.

WHEREAS, it was learned that the Sangguniang Bayan can declare working or non-working holidays in their respective localities to commemorate significant, historic events, provided however, guidelines shall be followed accordingly by virtue of Senate Bill No. 714 known as Local Holidays Act of 2010;

WHEREAS, as provided in Senate Bill No. 714, the guidelines to be complied prior the Sangguniang Bayan can declare working or non-working holidays provided under Section 4 paragraph (a) and (b) as stated:

- a) There must be prior certification by the National Historical Institute (NHI) as to the historical significance of the occasion.
- b) There must be prior consultation with the DOLE as to the economic viability of the holiday.

**WHEREAS**, this august body believed that Senate Bill No. 714 is now presently approved into law due to the span of time when it was passed on July 7, 2010;

**WHEREAS**, by virtue of the above-stated law, this august body take the opportunity to declare special non-working holidays during the founding anniversary of this town falls on June 17 every year and Subanen Day Celebration annually hence this request in aid of legislation;

**WHEREFORE**, premised of the foregoing consideration, and on motion of Hon. Daisy A. Limbang, duly seconded by Hon. Raul P. Dominise and Hon. Wencito B. Intoy, it was

RESOLVED, as this body hereby resolved by REQUESTING THE NATIONAL HISTORICAL COMMISSION OF THE PHILIPPINES (NHCP) AND THE DEPARTMENT OF LABOR TO ISSUE CERTIFICATION AS TO SIGNIFICANCE OF THE OCCASION AND ECOND VIABILITY OF THE HOLIDAY FOR THE SANGGUNIANG BAYAN TO DECLARE NON-WORKING HOLIDAYS OF THIS MUNICIPALITY.
