RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) UNIT BRAND NEW MULTI-PURPOSE UTILITY VEHICLE FOR SERVICE VEHICLE OF THE SANGGUNIANG BAYAN AND TWO (2) UNITS 4X4 PICKUP TRUCK (AUTOMATIC TRANSMISSION) FOR DISASTER RESPONSE AND RESCUE ACTIVITIES OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE.

WHEREAS, the local government unit had appropriated the amount of **Php1.8 million pesos** embodied in the Annual Budget FY 2024 under Appropriation Ordinance No. 24-01 dated January 15, 2024 for the purchase of One (1) unit brand new multipurpose utility vehicle (Van) for service vehicle of the Sangguniang Bayan;

WHEREAS, in a related instance, the local government unit is a recipient of Two (2) units 4X4 Pickup truck for disaster response and rescue activities of the MDRRMO from the Congressional Funds of Hon. Congresswoman Glona G. Labadlabad downloaded from the Department of Budget and Management amounting to **Php 3.8 million pesos**;

WHEREAS, the downloaded funds are not sufficient for the purchase of Two (2) units 4X4 PICKUP TRUCK (AUTOMATIC TRANSMISSION) with a market price of **Php2,282,975.00 pesos** each, hence, the MDRRMO had augmented the amount of **Php765,950.00** portion of the appropriated continuing appropriation in the amount of Php2.5 million pesos authorized under MDRRMC Resolution No. 01, series of 2023 duly adopted and was declare in order by the Sangguniang Bayan under Resolution No. 110, series of 2023, dated May 15, 2023;

WHEREAS, vehicles above-mentioned were classified under the authority of the DILG for the Local government unit to purchase provided various documents required shall be complied with;
