# **MEMORANDUM OF AGREEMENT**

Walang Gutom 2027: Food Stamp Program

## **KNOW ALL PERSONS BY THESE PRESENTS:**

This Memorandum of Agreement, hereinafter referred to as the "MOA", is made and entered into this 11th day of July, 2024 at **Siayan**, between and among:

The DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) - FIELD OFFICE IX with office address at General Vicente Alvarez Street, Zamboanga City, represented by its Regional Director, **RIDUAN P. HADJIMUDDIN, CESO IV**, herein referred to as "DSWD FO IX";

#### and

The LOCAL GOVERNMENT UNIT OF **Siayan, Zamboanga Del Norte**, with office address at Poblacion, Siayan, Zamboanga Del Norte, represented by its Mayor HON. **ALBERTO J. BONGCAWEL**, herein referred to as the "LGU **Siayan, Zamboanga Del Norte**".

#### WITNESSETH:

WHEREAS, by virtue of Presidential Executive Order No. 44, series of 2023, the "Walang Gutom 2027: Food Stamp Program" of the DSWD was declared as a Flagship Program of the National Government, with the DSWD as the lead implementing agency responsible for its management and execution;

WHEREAS, the "Walang Gutom 2027: Food Stamp Program" aims to decrease the incidence of involuntary hunger experienced by low-income families through the provision of Electronic Benefit Transfer (EBT) Cards, which can be used to purchase select food commodities at eligible partner stores and merchants;

**WHEREAS**, the DSWD is mandated to work with other National Government Agencies (NGAs) and Local Government Units (LGUs) for the program's implementation, requiring full support and cooperation to ensure effective execution;

**WHEREAS**, the DSWD Central Office has delegated the DSWD FO IX to coordinate with the LGU of **Siayan**, **Zamboanga Del Norte** for the implementation of the "Walang Gutom 2027: Food Stamp Program";

**NOW, THEREFORE,** for and in consideration of the foregoing premises, the parties hereto agree as follows:

#### I. RESPONSIBILITIES OF THE DSWD FO IX:

- A. Manage and supervise the implementation of the "Walang Gutom 2027: Food Stamp Program" in accordance with directives from the DSWD Central Office;
- B. Submit regular status reports on the implementation to the DSWD Central Office:
- C. Facilitate necessary procurements for the program's implementation;
- D. Supervise the staff/personnel assigned for the program's implementation;
- E. Maintain and make available all records and files related to transactions involving program funds upon request by the Commission on Audit (COA) Auditor;
- F. Implement program conditionalities, including but not limited to Nutrition Education Sessions and Productivity Enhancement Sessions, Skills Training, and Job Seeking Opportunities;
- G. Coordinate with other NGAs and international/local development partners to ensure smooth program implementation, including:
  - 1. Social Preparation;
  - 2. Market/Retailer Assessment;
  - 3. Accreditation of Merchants:
  - 4. Identification and Validation of Beneficiaries;
  - 5. Enrollment of Beneficiaries:
  - 6. Provision of EBT Cards;
  - 7. Payments to Eligible Merchants;
  - Monitoring and Evaluation;
  - 9. Provide necessary administrative support, including the release of salaries and benefits for the program staff assigned to the DSWD FO [Region]; and
- H. Establish and maintain a Walang Gutom Program Regional Management Office to oversee and coordinate program activities within the region.

### II. RESPONSIBILITIES OF THE LGU Siayan Zamboanga Del Norte:

- A. Endorse the "Walang Gutom 2027: Food Stamp Program" to the Barangay Local Government Units identified by the program implementers;
- B. Support and assist in the program's implementation by providing logistical support, including but not limited to:
  - 1. Venue for activities necessary for the program's implementation;

- 2. Logistics, equipment, generators, and other resources;
- 3. Coordination with DSWD FO IX for validation processes;
- 4. Validation of beneficiaries; and
- 5. Security, safety, and emergency response support for DSWD FO IX staff/personnel and beneficiaries;
- C. Designate a Focal Person for the program to assist DSWD staff in implementation; and
- D. Provide instructions, endorsements, and coordination with relevant offices, including the Municipal Social Welfare and Development Office (MSWDO), Business Permits and Licensing Office (BPLO), Municipal Nutrition Action Office (MNAO), Municipal Agriculture and Fisheries Office (MAFO), Public Employment Service Office (PESO), Technical Education and Skills Development Authority (TESDA), and include program concerns in LGU meetings.

#### III. ACCOUNTABILITY

The agreement shall be implemented according to the terms and conditions stipulated herein. Failure to comply with the provisions of this Agreement will warrant its discontinuance and may lead to administrative and/or criminal actions against responsible officers and employees of the erring party.

#### IV. APPLICABLE ORDER AND CODE

The program implementation and this MOA shall be in accordance with Executive Order No. 44, Series of 2023, and the Local Government Code of the Philippines.

### V. EFFECTIVITY

This Memorandum of Agreement shall take effect upon signing by the parties hereto and shall remain valid and existing until revoked or terminated by their mutual consent.
