BARANGAY SOGUILON ORDENANCE NO. 02

Series of 2024

AN ORDINANCE IMPOSING CURFEW HOURS TO MINORS AND ADULT FROM 12-YEAR-OLD AND ABOVE STARTED FROM 9:00 O'CLOCK PM TO 4:00 O'CLOCK AM AT BARANGAY SOGUILON, SIAYAN ZAMBOANGA DEL NORTE.

SPONSORED BY: HON. FELOMINO P. GUMANDAM

BE IT ORDAINED by the Honorable Sangguniang Barangay of Soguilon, Siayan, Zamboanga Del Norte in session assembled:

SECTION I. TITLE AND SCOPE. This ordinance shall be known as an ordinance imposing curfew hours to minors and adult aging from 12 years old and above started from 9:00 O'clock Pm to 4:00 O'clock Am on the following day at Barangay Soguilon, Siayan Zamboanga Del Norte. This ordinance shall cover all minors and adult residing transient or Visitors in this Barangay Soguilon.

SECTION II. DECLARATION OF POLICY. It is the duty of the government to put control and pass laws for the benefits of minors or youth and adult to lead and prepared them to the good and proper way of life. Imposing curfew hours on minors and adult shall greatly held in minimizing juvenile delinquent and recidivist in the community.

All minors and adult covering the ages provided herein violating hereof shall be apprehended and detail Barangay office prior to their release, the passes should be corresponding penalty herein provided and therefore be turn over the minors to the department of social welfare and development (DSWD) for counselling, guidance and other appropriate action. The payment will accrue to the refer of the local revenue code of Barangay Soguilon, Siayan Zamboanga Del Norte.

SECTION III. PROHIBITED ACTS. Minor and adult aging from 12 years old and above are prohibited to go out for their respective residents, home/houses, sleeping partners and the like from 9:00 O'clock Pm to 4:00 O'clock Am.

SECTION IV. EXCEPTIONS. Minors and adult are exempted in the imposition of this ordinance on the following instances.

(Section IV. Exceptions)

1. Emergency cases
2. Minors who are accompanied with their parents / guardians on their way home.
3. Students covering the herein specified ages who attended night school program/activities. Provided that the afforested students are within the premises where the school programs/activities held. All students have given grace time of 30 minutes after the program to go home
4. Youth affairs
5. Emancipated minors and adult who have to work date.

SECTION V. PENAL PROVISION. Any minors and adult who violates this ordinance shall be penalize in the amount of 500.00 pesos of first offense second offence 1,000.00 pesos and third offence and so forth 1,500.00.

SECTION VI. EFFECTIVELY CLAUSE. This ordinance shall take effect thirty days after approval and publications, public information and dissemination and posting to conspicuous places.


