RESOLUTION DECLARING TO DEMOLISH THE OLD AND DILAPIDATED, WEAK WAITING SHED PREVIOUSLY CONSTRUCTED WITHIN THE BARANGAY SITE WHERE THE CONCRETING OF THE FARM-TO-MARKET ROAD OF BARANGAY PANGE SHALL PASS THROUGH HITTING TWO OF THE MAIN POSTS OF THE OLD AND ALSO DILAPIDATED BARANGAY PUBLIC MARKET.

WHEREAS, the existing Farm-to-Market Road (FMR) of Barangay Pange is still classified as a dirt road due to the fact that every year the said access road to barangay Pange is although maintained by gravelling, during rainy days, the applied sand and gravel are washed out of the road carried by the strong current of surface water due to heavy rains that will last from one hour to eight (8) hours during the months of May, June, and other succeeding months especially during stormy weather conditions or stormy days;

WHEREAS, dirt roads in areas where the terrain is characterized from rolling to hilly are prone to strong runoff surface water that cause scouring and canal developments crisscrossing the dirt and graveled-dependent roads that makes transport vehicles hard to navigate and makes travel dangerous; thus is now funded for road concreting activities extending toward the barangay site of barangay Pange and for other future extensions to the surrounding sitios or communities;

WHEREAS, at the end of the road project, are previous two old and dilapidated structures that are within the span of the road concreting project, hence the old and weak waiting shed needs to be demolished; while the old and dilapidated barangay public market whose two main post on the western side are also within the span of the road concreting project, and shall be subject for renovation and improvement;

WHEREAS, the old and dilapidated Public Market Building of the Barangay that was made of light wooden materials and whose roof needs to be replaced with new premium galvanized iron sheets was constructed in the year 2004, while the old and dilapidated waiting shed was also made of light


NOW, THEREFORE, on motion of Barangay Kagawad Dalmacio A. Lubac, duly seconded by all Barangay Kagawad present, it was

RESOLVED, as it is hereby resolved, to demolish the old and dilapidated Waiting Shed, and to consider pulling down the two main posts of the old and dilapidated Public Market Building of Barangay Pange as an initial step for its renovation and improvement; and in giving way for the **construction and concreting of Macasing-Pange Farm-to-Market Road (FMR) that shall end at the location of the two-mentioned building structures of the barangay;**


RESOLVED FINALLY, to furnish copies of this resolution to the honorable body of the Sangguniang Bayan of Siayan for their information and favorable action;
