RESOLUTION REQUESTING THE LOCAL GOVERNMENT UNIT (LGU) OF SIAYAN FOR THE BLGU OF BARANGAY PANGE TO RENT THEIR HEAVY EQUIPMENT THAT WILL BE USED FOR SCRAPING AND GRAVELLING OF THE 2.5 KILOMETER FARM-TO-MARKET ROAD (FMR) TO THE BARANGAY CENTER OF PANGE, SIAYAN, ZAMBOANGA DEL NORTE.

WHEREAS, the barangay officials of barangay Pange in session assembled have agreed that its 2.5 kilometer Farm-to-Market Road that ends at the Barangay Center or Barangay Proper has to be scraped and gravelled to improve its existing muddy condition so as to promote better navigation and safe driving experience among habal-habal motorists who are serving the residents of the barangay not only in the transport of harvested agricultural crops, but also in transporting passengers from the barangay to Siayan's Commercial Center and back to the barangay; as well as in transporting teachers and students to their respective school destinations;

WHEREAS, scraping and gravelling activities requires the rental of appropriate heavy equipment and the corresponding operators including diesel fuel; thus, the BLGU of Pange will shoulder the costs in the provision of diesel fuel;

NOW, THEREFORE, in consideration of the foregoing premises, on motion of honourable barangay Kagawad Manuel G. Ebol, duly seconded by the rest of the barangay officials present, it was
