PREFATORY STATEMENT

The Barangay government of Moyo of this Municipality had established/ Constructed and maintained Hanging foot Bridge a Counter-parting scheme with the KALAHI CIDSS traversing Piao river Connecting Barangay Poblacion Lower Pase Moyo,unfortunately, motor Single Vehicle driver will also access to pass over the Hanging footbridge Particularly the motor for hire known as Habal-habal that Carries overloading weight capacity due to the dept water and hallow sand and gravel at piao River that Even a four wheeled vehicle Could hardly pass.

To prevent the Hanging footbridge from early and fast damages due to the passage of Habal-habal motor for hire carrying heavy or overloading cargoes ,hence this intent.

BE IT ORDAINED by the Sangguniang Barangay in Session assembled:

**"BARANGAY ORDINANCE NO.03**  
Series of 2024

**SECTION I.TITLE.** this shall be Known as " AN ORDINANCE REGULATING THE WIEGHT CAPACITY OF CARGOES CARRIED BY MOTOR SINGLE FOR HIRE KNOWN AS HABAL-HABAL INCLUDING OTHER MOTOR SINGLE VEHICLE OF ANY PERSON PASSING THROUGH THE HANGING FOOT BRIDGE CONNECTING BARANGAY POBLACION AND LOWER PASE,MOYO AND PENALIZING ANY VIOLATION THEREOF."

**SECTION II. WEIGHT LIMIT OF CARGOES** All habal-habal and other motor single service vehicle of any private person shall not carry cargoes and passengers more than ONE HUNDRED FIFTY (150) kilograms.

**SECTION III. PENALTY CLAUSE:** Any violation of this ordinance shall be penalized in the following cases:


- 1<sup>st</sup> Offense .....P 500.00
- 2<sup>nd</sup> Offense .....P 1,000.00
- 3<sup>rd</sup> Offense .....P 1,500.00


**SECTION IV.EFFECTIVITY:** This Ordinance shall take effect upon approval
