

**RESOLUTION REQUESTING THE LOCAL GOVERNMENT UNIT (LGU) OF
SIAYAN THRU THE LOCAL CHIEF EXECUTIVE HONORABLE ALBERTO "Ali "
J. BONGCAWEL FOR CONSTRUCTION MATERIALS FOR OFFICIAL USE IN
THE CONSRTUCTION OF A SPRING DEVELOPMENT AT BARANGAY PANGE.**

**WHEREAS, the barangay officials of barangay Pange in session
assembled have discussed on the necessity of developing a spring site**

for additional potable water supply especially during the dry season and the occurrence of an El Nino Phenomenon;

WHEREAS, the identified location of a water spring is 1,500 meters passing near the residence of Barangay Kagawad Rudy S. Lumigao towards the barangay site;

WHEREAS, the estimated required construction materials for the proposed spring development are the following, namely:

- 1) 10 sacks of Portland Cement;
- 2) 10 pcs of Re-enforced Round Bars (Kabilya # 10mm
- 3) 10 pcs of Re-enforced Round Bars (Kabilya # 12mm
- 4) 14 pcs of Coupling for PVC Water Hose
- 5) 1,500 -meter PVC Water Hose # 1 ½ in diameter

NOW THEREFORE, on motion of Barangay Kagawad Hon. Rudy S. Lumigao, duly seconded by all Barangay Officials presents, it was.

RESOLVED, as it is hereby resolved, to request from the local chief Executive of the Local Government Unit of Siayan honourable Municipal Mayor Alberto " Ali" J. Bongcawel for the officials use on the proposed priority project" Construction of Spring Development for additional source of potable water supply to anticipate another long dry season or the next occurrence of the El Nino Phenomenon and benefit at least 30 percent or more of the total household population of barangay Pange; and which construction materials are indicated below, namely:

- 1) 10 sacks of Portland Cement;
- 2) 10 pcs of Re-enforced Round Bars (Kabilya # 10mm
- 3) 10 pcs of Re-enforced Round Bars (Kabilya # 12mm
- 4) 14 pcs of Coupling for PVC Water Hose;
- 5) 1,500 meters PVC Hose # 1 ½ in diameter;and


- 6) Additional construction materials for at least 3 Tap stands that is hoped to be estimated by the Municipal Engineering Office concernad personnel.


