A RESOLUTION REQUESTING THE HON. GLONA C. LABADLABAD TO FILE A HOUSE BILL CONVERTING GUNYAN NATIONAL HIGH SCHOOL-BALUNOKAN EXTENSION INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO KNOWN AS BALUNOKAN NATIONAL HIGH SCHOOL

WHEREAS, Gunyan National High School-Balunokan Extension Class was opened in August 2017 in Barangay Balunokan, Siayan, Zamboanga del Norte to cater the incoming Grade 7 students from Balunokan Elementary. School and its neighbouring barangays;

WHEREAS, after six years of its opening, the Gunyan NHS-Balunokan extension class is left behind in terms of equity in infrastructure and resource allocation hindering it from delivering quality education;

WHEREAS, Article XIV, section 1, of the 1987 Constitution provides that, "The State shall protect and promote the right of all citizens to quality education... and shall take appropriate steps to make such education accessible to all."

WHEREAS, this body, cognizant to the mandate stated in Article XIV, Section 1 of the 1987 Constitution, desires to protect and promote the right of the students of Barangay Balunokan and takes appropriate steps to make such education accessible to all.

NOW, THEREFORE, premise on the foregoing, this body resolved as it is hereby resolved to REQUEST THE HONORABLE CONGRESSWOMAN GLONA C. LABADLABAD OF THE SECOND DISTRICT OF ZAMBOANGA DEL NORTE TO FILE A HOUSE BILL CONVERTING GUNYAN NATIONAL HIGH SCHOOL – BALUNOKAN EXTENSION INTO AN INDEPENDENT HIGH SCHOOL TO BE KNOWN AS BALUNOKAN NATIONAL HIGH SCHOOL;

RESOLVE FINALLY, to furnish copy of this resolution to the sangguniang Bayan of the Municipality of Siayan, Sangguniang Panlalawigan of the province of Zamboanga del Norte and finally to the office of Hon. Glona C. Labadlabad for appropriate action.
