WHEREAS, the barangay has the capacity to provide financial support for this essential need;


NOW THEREFORE, on motion of Hon. Jenieboy T. Bandivas, duly seconded by Hon. Dayline C. Bayhonon.


Resolved to request HON. MARIBEL C. OKAY to allocate funds for the materials needed for the completion of the makeshift classroom.

RESOLVED FINALLY, that a copy of this resolution be provided to the barangay council for their consideration and action.




