SCHOOL TO SITIO CROSSING & PANAGAYAN, SOGUILON SIAYAN ZAMBOANGA DEL NORTE WITH THE AMOUNT OF FOUR HUNDRED THIRTY ONE THOUSAND FIVE HUNDRED SIX PESOS AND FIFTY CENTAVOS (php 431,506.50)
