BITONGA TO DOWNLOAD FUNDS FROM 20% (FOR DEVELOPMENT PROJECTS) FOR THE CONSTRUCTION OF FREEDOM STAGE FOR GUNYAN NATIONAL HIGH SCHOOL, GUNYAN SIAYAN, ZAMBOANGA DEL NORTE AMOUNTING TO ONE HUNDRED NINETY THOUSAND SIX HUNDRED (190,600.00) PHILIPPINE CURRENCY.

WHEREAS, Gunyan National high School has limited funds and cannot undertake the said project due to budgetary constraints; there's a need for financial assistance on the identified and in need development for the welfare of the learning students/pupils and Teachers.

WHEREAS, after thorough study and discussion of the barangay official in session they come up with the unified decision to solicit counterpart from the Local Government Unit in response to the request of the Gunyan National High School.

WHEREAS, to cope up with; tripartite sharing was established and agreed viz; Local Government unit (LGU) funding assistance amounting to Php 279, 000, 00 in a form supplies and materials the Barangay Local Government Unit (BLGU) Download amounting to Php190, 600.00 in a form of transfer of funds to LGU for the supplies and materials the Barangay Local Government Unit will shoulder the Labor amounting to Php. 130,000.00 for the cost of the so called project.
