**"RESOLUTION NO. 237
Series of 2023**

RESOLUTION AUTHORIZING THE GRANT OF MEDICAL ASSISTANCE TO THE OFFICIALS AND EMPLOYEES WHO RENDERED SERVICES AT LEAST SIX (6) MONTHS AS OF OCTOBER 31, 2023 OF THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE IN THE AMOUNT OF TEN THOUSAND (P10,000.00) PESOS EACH.

WHEREAS, Section 447, par. (viii) of RA 7160 known as the Local Government Code of 1991 states: "Determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds";

WHEREAS, Memorandum Circular No. 33 of the Civil Service Commission (CSC) provides health programs and among others for the government and government owned controlled corporations (GOCC) Agencies;

WHEREAS, due to the economic conditions of all government employees had affected the prevalent prices of prime commodities, health maintenance, educational expenses, etc.. this august body adopted the Employees Compensation Program (ECP) to grant medical assistance in the amount of Php10,000.00 pesos provided however of the following prorate scheme:

Six (6) months above	One Hundred Percent (100%)
Four (4) months but less than Six (6) months	Sixty Percent (60%)
Three (3) months but less than Four (4) months	Fifty Percent (50%)


WHEREFORE, premised of the foregoing consideration, and on motion of Hon. Hon. Raul P. Dominise duly seconded by all members present, it was,


