**ORDINANCE No:01
Series Of 2022**

**AN ORDINANCE REVISING THE BARANGAY REVENUE CODE OF BARANGAY
GUNYAN, SIAYAN ZAMBOANGA DEL NORTE PURSUANT TO THE PROVISIONS
R.A.7160, KNOWN AS THE LOCAL GOVERNMENT CODE OF 1991.**

SECTION 1. TITLE

This ordinance shall be known as the Revising of Barangay Revenue code of 2022 of Barangay Gunyan, Siayan Zamboanga Del Norte.

SECTION 2. SCOPE

This ordinance shall govern the exercise of taxing, fees and service or user changes and other common revenue raising power of the Barangay which shall exclusively accrue to them;

SECTION 3. DEFINITION TERMS

As used in this ordinance, the following meaning and definition;

A. GROSS SALES OR RECEIPTS refer to the total amount of the money or equivalent representing the contract price, compensation or service fees, including the amount charges for materials supplied with the services performed or to be performed for another person. Excluding discounts if determined at the time sale/sales return, exercise tax and value added tax (VAT)

B. BUSINESS refers to trade of commercial activity regularly engaged or means of livelihood or with a view to profit.

C. AMUSEMENT refers to the pleasurable diversion and entertainment is synonymous to relaxation avocation past time or fun.

D. AMUSEMENT PLACES refer to theater's cinemas concert, cockpits, disco, houses balls, circuses and other similar places of amusement for one seeks admission to entertain oneself by seeing or viewing the show of the performers.

E. CARENDERIA refers to any public eating place for foods already cooked and serve at a price;

F. CHARGES refer to pecuniary liabilities as rents or fees against persons or properties

G. FEES refer to dues fix by laws or regulation, ordinance or inspection of business or undertaking

H. DEALER mean one whose business is to buy and sell merchandise, goods, animals and chattels as a merchant, she/he stands immediately between producers or manufacturer and the consumer and depends from his/her profits not upon the labor she/he below upon his/her commodities but upon the skill and foresight with which he/she watches the market.

I. OPERATOR refers to the owner, manager, administrator or any other who operates or is responsible for the operation of the business establishment or undertaking.

J. AGRICULTURAL PRODUCTS includes the yield of the soil such as corn, rice, coconut, roots crops, vegetables, flowers, fruits, and its products all kind of fish, poultry, livestock, and animal product whether in their original form or not.

K. COMMERCIAL BUILDING refers to all building located in a commercial area/centers including malls, market and the like.

L. LEVY means an imposition or collection of an assessment, tax tribute or fines.

M. LICENSE OR PERMIT is a right or permission granted in accordance with the law by a competent authority to engage in some business or occupation or to engage in some transaction.

N. PEDDLERS OF VENDORS refers to any person who either for him or commission, travel to place to place and sells his goods, offers to sell and deliver the same. Whether a peddlers or vendors are a wholesale peddler or a particular commodity shall be determined from the definitions of a wholesale dealers or retailer dealer.

O. PUBLIC UTILITY refer to as any vehicle propelled by any power using the public road such a tricycle, motorcycle (habal-habal) jeep, bus and the like.

P. TAX means enforced contribution usually monetary inform of lived by the law-making body and persons and properties subject to their jurisdiction for the precise purpose of supporting government needs.

SECTION 4. BUSINESS PERMIT

Any person or group of people who may invest any kind of business in Barangay Gunyan, shall secure business permit from the office of the Barangay Captain in the Php. 200.00/year.

SECTION 5. TAXES ON BUSINESS

All store or retailer with fix business establishments operating in the Barangay and with a gross sale or receipts of the preceding calendar year thirty Thousand Pesos (30, 000.00) or less shall pay Barangay Treasurer or the duly authorized deputy the corresponding taxes in the amount not exceeding one percent (1%) declaration on such gross sale or receipt in the corresponding taxes in the absence of said gross sales receipts the sworn statement declaration of sales of the owners operator or proprietor shall be used basis for taxation.

A. For purpose of this section buying and selling of goods in any place except those made by duly licensed establishment within the radius of 3 kilometer from the market compound to central market are considered made within the premises and subject to market fees.

Any person or group of persons that establish and build residential house within the Barangay site of Gunyan be charged in the amount 10.00 per month. Provided that said Barangay lot to be utilized by the Barangay government for project purpose the lessel shall be given a two (2) months grace period to transfer.

SECTION 6. BARANGAY CLEARANCE

The rate of fee to be collected for the issuance of Barangay Clearance shall be as follows.

SECTION 7. BARANGAY BUILDING PERMIT

All-natural resources within the jurisdiction of Barangay Gunyan which is explored, extracted quarried by a person, group of people, inventors' contractors mining corporations, concessionaries, hunters and like will secure trans portal permit from the office of the Barangay Captain.

SECTION 10. FEES AND CHARGES OF CUTTING TREES

SECTION 11. CHARGES FOR PARKING FEE

There shall be collected for the use of Barangay owned parking areas in accordance with the following schedule.

1. Passenger buses or cargo trucks	50.00
2. Mini buses or jeepneys	10.00

3. Habal-habal

SECTION 12. FEES AND CHARGES ON BILLBOARDS

The Barangay may levy the following fees and charges on billboards, signboards, neon signs and other outdoor advertisement. The sole basis of the number of the face of the board would not be considered and the rate of the would be as follows;

SECTION 18. COLLECTION

Pursuant to the provision of the preceding section, all taxes fees, charges shall be collected by the Barangay Treasurer or the authorized deputy, pursuant to section 170 Republic Act. 7160.

SECTION 19. SEPARABILITY CLAUSE

If for any reason, any part or provision of these ordinance shall be held unconstitutional or invalid, other parts of provisions thereof which are not affected there by shall continue to be in full force and effect.


SECTION 20. EFFECTIVELY

This ordinance shall take effect after approval of the Sangguniang Bayan of Siayan, Zamboanga Del Norte.
