RESOLUTION ENDORSING THREE (3) NOMINEES NAMELY MRS. MYRNA B. BACULPO, MRS. MERLYN H. MELINDO, AND MRS. ELY B. DIANITO FOR THE HONORABLE MUNICIPAL MAYOR TO SELECT ONE OF THEM TO BE APPOINTED AS THE NEW OSCA HEAD FOR THE NEXT THREE YEAR TERM FROM JANUARY 01, 2024 TO DECEMBER 31, 2026 SUBJECT FOR THREE MONTHS EXTENSION IN THE EXIGENCY OF THE SERVICE AS MANDATED UNDER SECTION 6 OF RA 9994 AND RULE VI, ARTICLE 21, SECTION 2 OF THE IRR OF RA 9994.

WHEREAS, the term of office of the Head of the Office of the Senior Citizens (OSCA) of the Local Government Unit of Siayan in the person of Mrs. Bebita D. Nalzaró is about to end on December 31, 2023;

WHEREAS, Section 2 of Article 21, Rule VI of the IRR of RA 9994 provides that an OSCA Head shall be chosen from a list of three (3) nominees as recommended by a general assembly of DSWD-accredited or LGU-registered senior citizens organizations in the city or municipality who shall be appointed by the mayor for a term of three (3) years without reappointment but without prejudice to an extension not exceeding three (3) months, if exigency so requires;

WHEREAS, the Board of Directors of the Municipal Federation of Senior Citizens Association of the Philippines, Siayan Chapter – a DSWD-accredited/LGU-registered senior citizens organization in the municipality, convened last November 07, 2023; and after a thorough exchange of opinions preferred to make a list of three (3) nominees for endorsement to the Municipal Mayor for him to select as to who shall be appointed as the next OSCA Head to serve the more than three thousand registered senior citizens in Siayan;

WHEREAS, the three (3) nominees are the following:

- 1) Mrs. Myrna B. Baculpo;
- 2) Mrs. Merlyn H. Melindo; and
- 3) Mrs. Ely B. Dianito

NOW, THEREFORE, premise considered, on motion of Board member Liberato Nalzaró, duly seconded by majority of the MFSCAP Officers present, it was
