RESOLUTION AUTHORIZING THE LOCAL GOVERNMENT UNIT (LGU) OF SIAYAN, ZAMBOANGA DEL NORTE REPRESENTED BY THE HON. MUNICIPAL MAYOR ALBERTO J. BONGCAWEL TO DONATE A LOT MEASURING ONE THOUSAND SQUARE METERS (1,000 SQ. M.) PORTION OF LOT NO. 20 COVERED UNDER TRANSFER CERTIFICATE OF TITLE NO. T-71718 OWNED BY THE LOCAL GOVERNMENT UNIT IN FAVOR OF THE BUREAU OF FIRE PROTECTION (BFP) FOR THE SITE OF BFP STATION IN THIS MUNICIPALITY AMENDING AND REBOOKING RESOLUTION NO. 012, SERIES OF 2022.

WHEREAS, the Local Government Unit of this municipality has been donated a portion of land authorized under Resolution No. 012, Series of 2022 dated February 21, 2022, containing an area of FIVE HUNDRED (500) SQUARE METERS portion of Lot No. 20 within the municipal government lot situated at Bagsakan area, Poblacion, Siayan, Zamboanga del Norte, intended for the site of Bureau of Fire Station building;

**WHEREAS**, the typical Fire Station building to be constructed in this municipality funded by the Bureau of Fire Protection (BFP) NHQ required 1,000 Sq. m. land area duly donated by the local government unit concerned;

**WHEREAS**, in order to comply the required total land area of the BFP building hence this authority to donate 1,000 square meter amending and rebooking Resolution No. 12, series of 2022, described as follows;

## **DEED OF DONATION**

## KNOW ALL MEN BY THESE PRESENTS:

This **DEED OF DONATION** is made and executed by and between:

The MUNICIPAL GOVERNMENT OF SIAYAN, ZAMBOANGA DEL NORTE, a government political subdivision, created under the laws of the Republic of the Philippines, with office address at the Municipal Hall, Siayan, Zamboanga del Norte, represented in this instance by its Municipal Mayor Hon. ALBERTO J. BONGCAWEL, hereinafter referred to as the DONOR:

The BUREAU OF FIRE PROTECTION (BFP), an agency of the Department of Interior and Local Government (DILG), responsible for implementing national policies related to firefighting and fire prevention as well as implementation of the Fire Code of the Philippines (RA 9514), represented in this instance by the Regional Director, CSUPT RENATO B. MARCIAL, with office address at BFL Bldng., Fernan St., Palmera, San Pedro, Pagadian City, hereinafter referred to as the DONEE.

## WITNESSETH:

That the **DONOR** is the owner in fee simple of a certain parcel of land containing an aggregate area of **ONE THOUSAND** (1,000) **SQUARE METER** portion of Lot No. 20 – PCS -09-003711 within the municipal government lot situated at Bagsakan area, Poblacion, Siayan, Zamboanga del Norte, bearing with Transfer Certificate of Title (TCT) No. T-71718, particularly described and bounded as follows:

On the North by national highway measuring 20 meters; On the south by remaining portion of lot No. 20 - PCS-09-0037611, measuring 20 meters; On the East by remaining portion of lot No. 20- PCS-09-0037611, measuring 50 meters; and on the West by Road Lot (Portion of Lot No. 233, measuring 50 meters; a total of 1,000 square meters;

That for and in consideration of local governance in ensuring public safety and for the welfare of the constituents related to the prevention of fire disaster and for effective implementation of the Fire Code (RA 9514) in this municipality, the **DONOR** through its representative and by virtue of Sangguniang Bayan Resolution No. 039, series of 2023, dated March 6, 2023 hereby freely transfer and convey, assign all the rights of the above-mentioned parcel of land by way of **DONATION** unto the **DONEE** which is free from all liens, encumbrances and charges whatsoever;

That the portion of land hereby donated is solely to be utilized for the site and construction of **FIRE STATION** of the Bureau of Fire Protection (BFP) in this municipality, provided however, if the donated lot be abandoned and not utilize for the main purpose herein manifested by the **DONEE**, this instrument will be cancelled and/or null and void;

That the **DONEE** hereby accepts the donation and heartily express its appreciation, gratefulness for the kindness and generosity of the DONOR.
