RESOLUTION DECLARING THE AMOUNT OF THREE MILLION TWO HUNDRED SIXTY ONE THOUSAND FOUR HUNDRED FOUR PESOS (PHP3,261,404.00) AS ACCUMULATED INCOME SOURCE FROM THE HEAVY EQUIPMENT RENTALS OWNED BY THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE.

WHEREAS, Barangays of Guibo, Pange and Macasing of this municipality are recipient of concreting of farm to market road (FMR) worth 4 million pesos each; support fund from the National Task Force to End Local Communist Armed Conflict under the FY 2022 General Appropriations Act, (RA No. 11639);

WHEREAS, Section 4.0, sub-par 4.2.3 of Local Budget Circular NO. 144 provides that the implementation of projects shall be by administration or contract if the local government concern has the capacity to implement;

WHEREAS, the local government unit of this municipality has the capacity to construct said projects being equipped of heavy equipment and technical personnel, however, rentals of heavy equipment based on the Program of Works (PA) shall be collected by virtue of Revenue Ordinance and accounted as income;

WHEREFORE, premised of the foregoing consideration, and on motion of Hon. Daisy A. Limbang, duly seconded by all Sangguniang Bayan Members present, it as

RESOLVED, as this body hereby resolved by DECLARING THE AMOUNT OF THREE MILLION TWO HUNDRED SIXTY ONE THOUSAND FOUR HUNDRED FOUR PESOS (PHP3,261,404.00) AS ACCUMULATED INCOME SOURCE FROM THE HEAVY EQUIPMENT RENTALS OWNED BY THE LOCAL GOVERNMENT UNIT OF SIAYAN, ZAMBOANGA DEL NORTE.
