PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES, MALACAÑANG PALACE, MANILA FOR A BUDGET ALLOCATION INTENDED FOR CONSTRUCTION OF TRIBAL HALL PER BARANGAY IN THE 22 BARANGAYS IN THE MUNICIPALITY OF SIAYAN, ZAMBOANGA DEL NORTE.

WHEREAS, in catering the needs of the constituents of the tribal community, a tribal hall is very beneficial to serve as the place of indigenous cultural communities to transact business;

WHEREFORE, premised of the foregoing consideration, and on motion of Hon. Wencito B. Intoy duly seconded by Hon. Roel J. Pabiran, it was
